

Terms & Conditions of Lucky Draw

The Changi Airport Community Charity Golf 2023 Dinner Lucky Draw (the “**Lucky Draw**”) will take place during the dinner event hosted by Changi Airport Group (Singapore) Pte Ltd (“**CAG**”) on 19 July 2023 at Tanah Merah Country Club (the “**Event**”). The Event is held by CAG for the benefit of Maitri School (in specific the “Maitri School/Building Project” Fund), under Metta Welfare Association and all donations are directed to Metta Welfare Association.

The following terms and conditions (“**T&Cs**”), and all subsequent revisions or amendments thereafter made by **CAG**, without prior notice, shall apply to the Lucky Draw.

1. The Lucky Draw will be held on 19 July 2023 (“**Draw Date**”), or such other periods as may be determined by CAG in its sole and absolute discretion.

Eligible Participants

2. As a condition of entry into the Lucky Draw, each participant affirms and represents that he/she is above 18 years of age and agrees to be bound in all respects by these T&Cs.
3. All donors, sponsors and their respective invited guests will be entitled to attend the Event (collectively “Guests”). Only Guests who have registered for and attend the Event are eligible to enter into the Lucky Draw (“**Eligible Participants**”).
4. All employees of CAG are not eligible to enter into the Lucky Draw.

Lucky Draws

5. At the Event, each Eligible Participant will be provided a ticket (“**Ticket**”) corresponding to their name and a unique serial number. In order to be enrolled into the Lucky Draw, the Eligible Participant will be required to drop their Ticket into a designated box on the Draw Date.
6. Participation in the Lucky Draw entitles an Eligible Participant a chance to win the Prizes (as defined in paragraph 12).
7. During the Draw Date, two (2) draws will be conducted as follows:
 - a. Draw 1 – Manual draw

Fifty-five (55) Eligible Participants will be randomly selected for prizes through a manual selection. The lucky draw will be conducted using a manual draw methodology, where Tickets will be drawn from the box. A designated CAG representative will be responsible for conducting the draw in the presence of a scrutineer who is not associated with CAG or otherwise involved in the conduct of the Lucky Draw. This process will be repeated until the required number of winners is determined. Draw 1 will be conducted in two parts, namely: part in front of an audience that is open to the public and part in the presence of a scrutineer. For prizes that are drawn in front of an audience, the winners will need to be present and respond when their names are called, otherwise, a redraw

will be carried out for the prize in question. Eligible participants will only be entitled to win one Prize under this Draw 1.

b. Draw 2 – Random computerised electronic draw for the grand prize

One (1) Eligible Participant will be randomly selected to win the grand prize through a random computerised electronic draw. This will be done in the presence of a scrutineer who is not associated with CAG or otherwise involved in the conduct of the Lucky Draw. The winner of the grand prize will need to be present for the draw and respond when their name is announced on stage, failing which another prize winner will be selected through the random computerized electronic draw. There will only be one (1) grand prize awarded during the Lucky Draw.

8. The selection of winners for the Lucky Draw (“**Winner(s)**”) will be held at Tanah Merah Country Club, Tampines Course on 19 July 2023, between 7.30pm to 10pm.
9. The Winners will be notified through an announcement or on-screen display at the Event on the Draw Date. In order to claim their respective prize, the Winner is required to furnish to CAG and/or their authorised representatives the Ticket and their details such as their name and email address for:
 - a. verification of their identity;
 - b. communication to any third party sponsoring the prize; and/or
 - c. publication on CAG’s designated website for the Lucky Draw.

- c. to promote and advertise the Event..

19. CAG reserves the right to engage authorised photographers and videographers to take photographs and/or video recordings. By participating in the Lucky Draw, Eligible Participants consent to being photographed and recorded by authorised photographers and videographers and consent to CAG's use of such images, films or recordings for creating marketing and publicity materials for public transmission.
20. Eligible Participants who fail to provide true, correct and accurate information when participating in the Lucky Draw shall automatically be disqualified from the Lucky Draw.
21. CAG and/or the Prize sponsors make no representation, warranty or undertaking whatsoever as to any implied terms or conditions with respect to any Prize. The Prizes provided are on an "as-is" basis.
22. The Prizes are non-exchangeable, non-transferable and no cash alternative will be offered. Where Prizes contain a specific date during which the Prize should be utilised, no requests for extensions or replacements whatsoever will be entertained. CAG, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner and/or Eligible Participant or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize or participation in the Lucky Draw except where it is caused by the negligence of CAG, its agents or distributors or that of their employees. To the maximum extent permitted by law, each Winner and/or Eligible Participant agrees to indemnify CAG against any losses, damages, costs, expenses, claims or liabilities of any kind arising in connection with his or her participation in the Lucky Draw.
24. The decision of CAG regarding any aspect of the Lucky Draw is final and binding and no correspondence will be entered into about it.
25. CAG reserves the right to hold void, cancel, suspend, or amend the Lucky Draw at its sole and absolute discretion.
26. By participating in the Lucky Draw, the Eligible Participant agrees to be bound by and to comply with these T&Cs including all amendments, additions, replacements and modifications hereto as may from time to time be made by CAG. CAG reserves the right to refuse entry or refuse to award the Prize to anyone in breach of these terms and conditions or as determined under its sole and absolute discretion.

27. The T&Cs are not intended to confer rights to any third party under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any provision of these T&Cs, and the operation of the said Act is hereby excluded.
28. The Lucky Draw shall be governed by Singapore law and all Winners and/or Eligible Participants agree to submit any claim, dispute or controversy to the non-exclusive jurisdiction of the courts of the Republic of Singapore.
