

**Jewel Changi Airport's "Sparkling Christmas at Jewel" Promotion**  
**(the "Promotion")**

**Terms and Conditions**

Promotion is valid from 19 November 2020 to 3 January 2021, unless otherwise stated and while stocks last.

**(A) Spend & Redeem Promotion**
