



## **Terms & Conditions**

### - **Shopping Promotion**

- All Promotions are valid from 6 Jan to 2 Feb 2020 unless otherwise stated.
- Minimum spend of S\$88 nett in two(2) same-day receipts from any participating Retail and F&B outlets to redeem a set of exclusive Disney's Frozen II red packets.
- All redemptions are to be made on the same day of purchase(s) and receipts can only be used once for redemption.
- Duplicated receipts will not be accepted for redemption.
- Limited to one redemption per shopper per day, regardless of amount spent in excess of the Minimum Spend Requirement.
