

Jewel Changi Airport's "Fall All In For You" Promotion (the "Promotion") Terms & Conditions Governing the OCBC Mastercard Jewel Changi Airport Promotion

- 1. Promotion is valid from 5 September 2025 to 20 October 2025, unless otherwise stated.
