

## Jewel Changi Airport's "Sparkling Wonders of Christmas at Jewel" Campaign

## **Terms & Conditions**

- Shopping Promotions
  - All Promotions are valid from 21 Nov 2019 to 5 Jan 2020 unless otherwise stated and while stocks last.
  - Admission terms apply to the Shiseido Forest Valley daily from 5pm to 11.30pm. Redemption is valid for every \$50 nett spend. Admission timing will be allocated based on a first-come-first serve basis. Shoppers can redeem admission for up to 10 people to the Shiseido Forest Valley per receipt transaction, while stocks last.
